5. Bids must be submitted to the office of the sunawarshi municipality by electronically on before 12:00 noon on 2078/05/28. Bids received after this deadline will be rejected.

Bids must be valid for a period of 90 days and must be accompanied by Bid security, which shall be valid for minimum of 30 days beyond the Bid validity period.
