Bids must be valid for a period of 90 days and must be accompanied by Bid security, which shall be valid for minimum of 30 days beyond the Bid validity period.
7. If the last date of purchasing, submission and opening falls on government holiday then next working day shall be considered the last date. In such case the Bid validity and Bid security shall Remain the same as specified for the original last date of Bid submission.
