5. Bids must be submitted to the office of the sunawarshi municipality by electronically on before 12:00 noon on 2082/08/28. Bids received after this deadline will be rejected.

6. The Bids will be opened in the presence of Bidders representatives who choose to attend on Mangsir, 28, 2082 13:00 hrs at sunawarshi municipality Dainiya, Morang. Bids must be valid for a period of 90 days and must be accompanied by Bid security, which shall be valid for minimum of 30 days beyond the Bid validity period.

7. If the last date of purchasing, submission and opening falls on government holiday then next working day shall be considered the last date. In such case the Bid validity and Bid security shall Remain the same as specified for the original last date of Bid submission.

8. The employer reserves the right to accept, or reject, wholly or partly any or all the Bids without assigning reason whatsoever.

9. Any additional matter not recovered by this shall be in accordance with the prevailing public procurement Act 2063, and public procurement Regulation 2064 of GON.
